Hyundai Motor commenced commercial operations in the United States in February 1986, with a sole model, the Hyundai Excel. The Excel was offered in a variety of trims and body styles. In 1986, Hyundai set a record of selling the most automobiles in its first year of business in the



United States compared to any other car brand; total sales in 1986 were 168,882.

Hyundai Motor has a US\$30 million design facility is fitted with the world's most advanced visualization, graphics, and clay-modelling technologies, keeping Hyundai at the forefront of car technology and design. Its' 190,000-square-foot state-of-the-art engineering and technology centre is home to hundreds of America's brightest engineers. They drive innovation with cutting-edge ergonomic design and power-train tuning, working to create the next great car.

Hyundai invested \$1.1 billion for building one of the most advanced manufacturing facilities in North America. It has received ISO/TS 16949 certification that is the most rigid quality management standard from the International Automotive Task Force.

In Alabama, Hyundai has one of the most advanced manufacturing facilities in North America, primarily producing the Elantra and Sonata passenger car models. Besides, it also operates an engineering facility in Michigan and design, research, and testing centres in California. Hyundai vehicles are distributed throughout the US by Hyundai Motor America and are sold, serviced through more than 800 dealerships nationwide. North America is one of parent Hyundai Motor's smaller markets.

As of 2011, Hyundai Motor recorded to be the world's fastest growing automaker for two years running. In 2010, the company sold over 3.6 million vehicles worldwide. Hyundai vehicles are sold in 193 countries through some 6,000 dealerships and showrooms. Hyundai has technologically sophisticated manufacturing facility in Montgomery, Alabama, engineering facilities in Michigan, plus design, research, and testing grounds in California.

The company provides around 5,000 jobs for American automotive workers. Hyundai also accounts for more than 20,000 employees at Hyundai dealerships and 6,000 workers employed by our various vendors.
