

## **Montana Government Jobs**

**Introduction-** As per the constitution of Montana, the state government is made up of three branches- the Legislative, Judicial and the Executive. The state legislature is composed of a Senate with 50 members, a House of Representative with 100 members and 2 chambers.



**About Montana Government:** According to Montana Code Annotated, the administration of the laws of the state is carried out through the chief executive, i.e. the governor, Lieutenant Governor, State Auditor, Superintendant of the Public Instruction, Attorney General, Secretary of the State and by the employees and staff members of the branch agencies.

The state currently operates with 14 main departments. The state constitution has made provisions for establishing temporary commissions which may not be allocated within the department.

**Employment at the Montana Government: Montana Government Jobs** cover a wide variety of areas and industries and offer applicants with plenty of choices, room for growth, excellent pay packages and benefits. All employees to the state government are eligible for fifteen vacation days, 10 holidays, 12 sick days and complete dental and health benefits, retirement and life insurance.

Montana Government has an equal opportunity employment policy. All the agency managers promote work environments that are inclusive and offer employees all the resources and support they need to reach their full potential and recognize their individual differences which may be key to team and organizational success. It treats all employees with respect and dignity.

Careers in Montana Government include mandatory membership in PERS, the retirement system. This retirement system offers death, disability and retirement benefits to more than 27,000 local, state and school district government employees. The State also has a comprehensive insurance benefits plan including options with vision exam and prescription drug coverage, life insurance, dental plan, long term care, flexible spending accounts and employee assistance program.

Jobs in Montana Government also include a voluntary deferred compensation program which is a supplementary retirement plan authorized by Montana law and Internal Revenue Codes. This program allows employees to defer certain amounts from their current income through payroll deduction. The benefits are tax deductible and available upon retirement.
